OFFICIAL RULES AND REGULATIONS

NOTE: These rules and regulations have been revised based on input from the 2013 All Ontario Organizing Committee & Past Participants

1.0 GOVERNING RULES AND REGULATIONS

1. The All Ontario Native Fastball Tournament; formerly the All Ontario Indian Men's and Women's Fastball Tournament, shall be governed by the playing rules of the Canadian Amateur Softball Association (CASA). Batting line-ups will only consist of 9 players.

2.0 PARTICIPATION

2.1 TEAM PARTICIPATION

2.1.1 First Nation community teams or affiliated Native Organization teams such as a Friendship Centre, Metis Local or Native Women's Chapter will be accepted.

2.1.2 The All Ontario Native Fastball Championships shall have five (6) divisions: Men's, Women's, Men's Masters, Women's Masters, Youth Boys and Youth Girls.

2.1.2.1 Men's Division (Open) will have a minimum of four teams and a maximum of sixteen teams participating.

2.1.2.2 Women's Division (Open) will have a minimum of four teams and a maximum of twelve teams participating.

2.1.2.3 Men's Masters (40+) Division will have a minimum of 4 teams and a maximum of 12 teams participating.

2.1.2.4 Women's Masters (35+) will have a minimum of 4 teams and a maximum of 12 teams participating.

2.1.2.5 Youth Division – Boys & Girls divisions - (15-18 years of age) will have a minimum of 4 teams and a maximum of 12 teams participating

2.1.3 All age determinations are effective August 25, 2017. In other words, if a player turns 19 on August 25th, 2017, they are not eligible for Junior Division. If they turn 19 on August 28th, 2015, they would be eligible. This is effective for all divisions with an age category associated with it. Masters divisions you have to be of age at the time of the tournament. (40+ for Men's & 35+ for women's). No underage players will be allowed for the master's divisions. If you are 16 or 17 and wanting to compete in the men's or women's division, you must have parental consent.

2.1.4 Each team participating in the All Ontario Native Fastball Championships shall not exceed the player limit of 20 players per team.

2.1.5 Player pick-up limits are intended to balance competition, encourage community to community competition and have been adopted from guidelines similar to other events where First Nation communities compete against one another. Pick up rules will not apply to the master's and youth divisions.

2.1.5.1 First Nations with less than 1000 members will be permitted to pick up seven (7) players from other First Nation communities or Aboriginal groups.

2.1.5.2 First Nations with less than 2000 members will be permitted to pick up four (4) players from other First Nation communities or Aboriginal groups.

2.1.5.3 First Nations with less than 5000 members will be permitted to pick up one (1) player from other First Nation communities or Aboriginal groups.

2.1.5.4, First Nations with more than 5000 members will not be permitted to pick up players

2.1.5.5 A team representing a Native Organization will be required to have all players registered as members of the respective organization.

2.1.6 Native communities with less than 500 residents who are unable to field players for one team are encouraged to join together with another community as one team to participate in the All Ontario Native Fastball Championships. In this instance, the combined membership of the partnering communities would be used to determine population assessment pertaining to pick-up players in Section

2.2 PLAYER PARTICIPATION

2.2.1 In order to qualify for participation in the All Ontario Native Fastball Championships a player must be Native, and belonging to an Ontario band or native residing in Ontario for more than 6 months.

2.2.2 All players shall be expected to play for their respective First Nation (where they are a member, not where they currently reside) unless a release is obtained. If a player resides in the community for longer than 6 months they will be eligible to play for that community. If a players' community does not have a team entered, a release is not required. Where a release is required, it must be in the form of a signed written release from the team; coach or manager of the players' First Nation or the Executive Director of First Nation Organization.

2.2.3 All releases must be submitted on the Official Release Form . In the event that you are not participating with your home community and wish to play for another First Nation you must obtain releases from each community (geographically closer) between your home First Nation and the First Nation you are participating with if they have a team entered.

2.2.4 Players, other than pitchers may participate in more than one Division if they qualify. i.e. a First Nation player that is 40+ years old may play in both the Masters and Men's Open divisions or a player that is under 18 may play in both the Youth and Men's Divisions.

2.2.5 Pitchers, under no circumstances, will not be permitted to pitch in more than one division.

3.0 EXECUTIVE COMMITTEE

3.1 The Executive Committee shall act as the official interpreter of the rules and regulations and shall render all final decisions on scheduling, protests and disputes. These decisions shall be based on the majority rule of those members in attendance at a meeting.

3.2 The Executive Committee shall consist of five (5) volunteer members as selected by the host committee and will be formed by invitation to respected and experienced former and current fastball players/organizers. The Executive Committee will consist of:

3.2.1 The Tournament Convener. The Tournament Convener will act as Chair of the Executive Committee

3.2.2 One additional member of the Host First Nation Community.

3.2.3 Three members from other First Nations or First Nation organizations with the intent that participating teams will be fairly represented. A Vice Chair of the Executive Committee will be elected by Executive Committee at their pretournament meeting.

3.3 The Executive Committee will have a minimum of two meetings: A pre-tournament meeting to review and accept the official rules of the tournaments and a post-tournament meeting with a brief report of incidents to be forwarded on the next year's organizing committee.

3.4 For interpretation purposes regarding the CASA rules, the designated umpire in chief for the tournament shall be consulted, however, he/she does not have a vote in Executive Decisions.

3.5 Any Executive Committee member who is connected with a team, as a player, coach, manager, trainer or band member of that team, shall rule themselves out from that committee decision in the event his/her community team is involved in a protest and or dispute

3.6 Any Executive Committee member who is a family member / partner with a player involved in a protest / dispute such a parent or grandparent, spouse and or partner, immediate or step sibling, aunt, uncle or 1st cousin, shall rule themselves out from that committee decision.

3.7 It is recommended that two Executive Committee Members be carried forward to the 2018 All Ontario Native Fastball Championships.

3.8 Communities wishing to host the 2018 All Ontario Native Fastball Championships in their community are encouraged to bring a sealed written request addressed to the Executive Committee and provide it to the Registration desk where it will be forwarded and an award decision can be made.

4.0 PROTESTS AND DISPUTES

4.1 A participating team may submit a written protest to the Tournament Convener and such protest shall be accompanied by a protest bond of three hundred dollars (\$300.00) in cash. Written protest and bond must be submitted no later than ½ hour after completion of the game in protest. Prior to the game ending, the umpire must be notified that the game is played under protest.

4.2 The Executive Committee shall meet and render its decision as quickly as possible.

4.3 Should the Executive Committee rule in favour of the protesting team; the protest bond shall be returned. Should the Executive Committee rule against the protesting team, the protest bond shall be forfeited back to the host.

5.0 PLAYER ROSTERS

5.1 Player rosters must be completed in the following manner and submitted to the Host community approximately four (4) weeks prior to the All Ontario Native Fastball Championships (August 11, 2017 for this year's tournament)

5.2 Team Management, the coaching staff and all players names must be typed or clearly printed on the official "Team Registration/Team Roster" Form. Areas for name, status card # and home First Nation are mandatory.

5.3 "Player Waiver of Liability" forms must be completed for all players and submitted at tournament registration one hour prior to the first scheduled game. Parental consent signatures on these forms are a requirement for players who are under 18 years of age.

6.0 ENTRY FEE

6.1 An entry fee of five hundred dollars (\$500.00) and player rosters shall be received by the Host community no later August 11, 2017

6.2 All entry fees shall be in the form of a CERTIFIED CHEQUE or MONEY ORDER. Any team failing to satisfy this requirement shall be deemed ineligible to participate in the All Ontario Native Fastball Championships.

7.0 PERFORMANCE BOND

7.1 A performance bond of two hundred dollars (\$200.00) in the form of a CERTIFIED CHEQUE or MONEY ORDER shall be sent to the Host community no later than August 11, 2017. The performance bond is to ensure that all participating teams remain to either the completion of the tournament or to elimination and will be reimbursed to the Manager of the team upon successful compliance of this rule. The performance

bonds can also be revoked by the Executive committee at their discretion (ie. Not full uniforms, conduct, intoxication, forfeits, etc.)

8.0 OFFICIALS

8.1 Only CASA recognized umpires shall officiate games at the All Ontario Native Fastball Championships and shall be the responsibility of the host community.

9.0 TOURNAMENT SCHEDULE

9.1 The All Ontario Native Fastball Championships shall guarantee two (2) games for each team.

9.2 Every attempt will be made to seed the top 4 teams from the previous year in separate brackets, 1st and 4th in the top half and 2nd and 3rd in the bottom half. The remaining teams will be randomly drawn and placed in alternating brackets – top, bottom, top, bottom, etc. until all of the bracket positions are full.

10.0 PRIZE STRUCTURE

10.1 In divisions where there are 16 teams, the prize money to be distributed for the All Ontario Native Fastball Championships will be: \$2,000.00 for 1st place, \$1,000.00 for 2nd place and \$500.00 for third place.

10.2 In Divisions where there are 12 teams, the prize money to be distributed for the All Ontario Native Fastball Championships will be: \$1,500 for 1st place, \$750.00 for 2nd place and \$400.00 for 3rd place.

10.3 In the event that a differing number of teams are in a division, the Host First Nation Organizing Committee will finalize and post the prize money to be offered prior to the first pitch of the tournament.

11.0 LENGTH OF GAME

11.1 All games in the All Ontario Native Fastball Championships shall be seven (7) innings in duration or one (1) hour and thirty (30) minutes, whichever occurs first.

11.2 A new inning will not commence after one hour and twenty minutes. The seven (7) run "mercy" rule shall be utilized after five (5) complete innings. The exception to this rule is in the semi-finals and championship games.

11.3 Games ending in a tie shall be completed with the "international rules" in the preliminary rounds.

11.4 Games may start earlier than the posted time and teams are expected to be ready for play 15 minutes before the scheduled start time.

11.5 No warm-ups are allowed on the playing field prior to or during the game.

11.6 The "Grace Period" for team lateness is 15 minutes from the schedule start time. Once the 15 minutes expires, the team in attendance will be awarded the win. If the team fails to show up on time and a game is forfeited, their performance bond is lost as per rule 7.0.

11.7 In the event of an injury on the field, the umpire may add on additional time to the game for the time lost.

12.0 PARTICIPANT CODE OF CONDUCT AND PENALTIES

12.1 The participant code of conduct will be patrolled and enforced by the Officials, the official scorekeepers, the Convener and the Executive Committee.

12.2 The decisions set out by the Officials and the Executive Committee of the Championships are final and are in effect immediately following the decisions.

12.3 The decision for ejection from a game rests with the officials of that game.

12.4 The decision for further disciplinary action rests with Executive Committee of the Championships.

12.5 Any player, coach, manager or trainer, who physically or verbally assaults an umpire, opposing player, fan, or officer of the tournament, during or after a game, shall be ejected from the game. Officials are to report the incident to the Tournament Convener for a disciplinary ruling on further penalties by the Executive Committee.

12.6 In order to promote and provide positive leadership and role models, abusive language, gestures and conduct will not be tolerated. Intolerant behaviour shall be reported to the Tournament Convener by officials or official scorekeepers. The Convener will assess the infraction and may issue a warning or bring the incident to the Executive

Committee for further action up to and including expulsion from the Championships.

12.7 If a runner is attempting to "bowl over" for the purposes of dislodging the ball or injuring the opposing player at any position, the runner is out and shall be ejected from the game. Officials are to report the incident to the Tournament Convener for a disciplinary ruling on further penalties by the Executive Committee.

13.0 UNIFORMS AND EQUIPMENT AND FIELD OF PLAY

13.1 All players on a team shall be dressed in a standard baseball uniform. Team jerseys must be of uniform color and it is preferred that all teams have two jersey colors to ensure distinct difference to the opposing team.

13.2 Full earflap helmets are mandatory for batters and must be worn while running bases as well.

13.3 Helmets are mandatory for catchers when catching.

13.4 Jewellery such as: wristwatches, bracelets, rings and neck chains shall NOT be worn in the Championships. Medical bracelets are the exception to the rule.

13.5 Metal spikes shall be permitted to be worn in the tournament for the Men's Open and Masters Divisions.

13.6 All bats used during the All Ontario Native Fastball Championships must comply with rule 3-1a of the Softball Canada Rulebook which states that bats must comply with the current A.S.A. (Amateur Softball Association) bat standards.

13.7 The Tournament will be using Worth K MASTER 120 balls.

13.8 The ground rules for each field of play will be explained to Manager's prior to each game.

13.9 The official pitching distance is: Men Open and Masters Divisions is 46'; Ladies and Junior Divisions = 43'

13.10 The official baseline distance is 60' for all divisions.

14.0 AWARDS

14.1 Individual trophies and awards may be awarded at the discretion of the Host First Nation Organizing Committee and will be posted prior to the first pitch of the tournament.

14.2 Championship trophies are available and may be taken home by the winning teams; however, the recipients are responsible for any damages, engraving and delivery of said trophies to the Host community the following year.

15.0 INJURIES

15.1 The All Ontario Native Fastball Championships shall not be responsible for any injuries that may occur to participants or spectators at the All Ontario Native Fastball Championships.

16.0 DAMAGES

16.1 Each team participating in the Championships shall be responsible for the conduct of their players and for any and all damages that may occur during the All Ontario Native Fastball Championships to any facilities or assets.

17.0 ALCOHOL/DRUGS

17.1 Any player, coach, trainer or manager who is found to be under the influence of alcohol or drugs shall not be allowed to play in the Championships.
